Abstract

The Plymouth United Savings Bank operated in Plymouth, MI on Main Street. The bank later became the National Bank of Detroit. After the National Bank of Detroit left, the building was converted into a children themed play café.

Scope and Content

The Plymouth United Savings Bank record group consists of banking records such as drafts, check books registers and trust certificates. There are also certificates of preferred and capital stocks. These records range from 1902 through 1952. Minutes from the Board of Directors included in the collection range from 1908 to 1949.
